

INSTALLATION

For configuration of the spotlight, the external module with display and touch-sensitive operating elements is connected to the spotlight using a special 2 m connection cable (connection cable included). Make sure that the connections are tightly sealed and that moisture cannot penetrate the spotlight housing and/or the display module housing. Once configuration of the spotlight has been completed, the module must be disconnected from the spotlight and the connection on the spotlight must be securely closed using the cover cap. The module can now be used to configure additional spotlights. Operation of the spotlight using the external display module is described in detail in the user manual of the corresponding spotlight.
